## **Expression of Interest**

### **Expression of Interest for providing consultancy services for replacement of 200 meter long imported drag ski lift at Gulmarg (J&K) having capacity of 250 skiers per hour.**

The Indian Institute of skiing & Mountaineering (IISM), Ministry of Tourism, Government of India invites Expression of Interest (EOI) from reputed consultancy organizations/ consultants in India having appropriate expertise and experience for providing consultancy services for installation of ski lifts in India, (i.e. preparation of drawings & detailed technical specifications for the purpose of floating Tender, also supervising the work and other fulfilling the legal and technical aspects for replacement/installation of ski-lift in the premises of IISM, Gulmarg).

#### **Background and objectives**

The IISM is a subordinate office of the Ministry of Tourism, Government of India which has been setup in the year 1968 in order to promote adventure tourism in the country. The IISM trains thousands of youth/ adventure lovers annually and some of them earn their livelihood from the training with the IISM.

#### **Eligibility Criteria**

Following are the eligibility criteria to be satisfied by the consulting firm / Consultant and all documentary evidences to substantiate the given information need to be submitted to this office for perusal. Applicants failing to meet the mandatory pre-qualification criteria, based on documents submitted by them, shall not be considered for further evaluation.

- i. The Consultant must be a Graduate (BE / B.Tech) in Architecture / Civil / Structural/ Mechanical engineering discipline from recognized Engineering college. Copy of degree qualification certificate to be submitted.

Note: Diploma / PG diploma / AMIE / or any other qualification other than above mentioned degrees will not be accepted.

- ii. Consultant should submit the copies of GST, PAN.
- iii. Consultant should furnish the proof of work experience. Copy of at least one work order of value above Rs.5.00 Lakh (or) two work orders value of above Rs..00 Lakh of civil consultancy done within the last five years ending 2021-22.

**B. Scope of Work**

- i. Preparation of Drawings & detailed technical specifications with estimated cost (based on market rates) for the purpose of floating Tender and for getting necessary statutory approvals / planning permissions.
- ii. Supervising the work of installation the ski lift and providing technical guidance to the IISM.
- iii. The TDS on fees for services will be deducted as per norms.

**Termination Clause:**

In case the performance of the Consultant is not found to be satisfactory, the contract will be terminated. The Principal, IISM has the right to terminate the contract any time and any stage of work without assigning the reasons.
